Dear Mr. Robison:

In reply to your request to Mr. Chas. B. Cook, March 18th, relative to the explanation of distances shown on plat enclosed with field notes for Section 26, Block 32, Township 2 N. in Howard County, Texas, will state that I began at the Northeast corner of Section 36, which is the Southest corner of Section 25, Block 32, said point being an old established corner on the east block line of this block, and ran West to the Southeast corner of Section 29 to determine the amount varas between these points , which was established in running the land for L.S.Hamlin some years back.

The corners called for in the Survey for Hamlin were on the ground and lined up with the work I have just done, and the distance they show for the lines North and South throughout the block on the West side is 1892 varows, but on the East I measured the line North on the East line of Section 25 and find another corner to be 1900.8 var as from which I proated the distance North and South between the three sections East of the Gail road leaving the Surveys West of the road as I found them. The distance East and West along the North line of Sections 25, 26 las shown on plat .

You will note that I have the Survey of the West half of the West half of Section 28. You, nodoubt, have before you by the time this reaches you a copy of field notes for that tract .

As there was no Survey on record in this County on the East half of this Block I concluded it better to proate the distances on these lines as I have shown them rather than try to tare up the work that was done on the West side of the Block.
