

the latter ones

I have no dates in which name the blank survey
#030 by 1820 north of Danl Johnson was returned
if it be Charles Richardson you will see
no conflict the Danl Johnson Survey comes
200 acres S. 80' from the S.E. corner of Danl
Robinson labor please take notice there are 2
Danl Robinson one is a part of $\frac{1}{3}$ league the other
a labor the whole $\frac{1}{3}$ league of Danl Robinson was
located in 1839 and covering all the ground between
the labor of P. Cornelius & S. Robinson the Danl Robinson
labor was located directly below at the same time
in 1846 the owner of the $\frac{1}{3}$ league not being able to
have the patent on account of the conflict with Miguel
Rebago relinquished and had cut off by survey
all but 600 acres which was surveyed in 46
as represented your please take notice
on the old maps the survey of Danl Robinson
Junior $\frac{1}{3}$ league was represented as made in 39
the labor of Danl Robinson Senior P. Cornelius
where made and patented according to the old
representation and of course the Danl Johnson

survey below it with 3 surveys when supposed
to be patented with out noticing the usual red
line of the 11 League grant surrounding them but
when on subsequent application Deuel Robinson
could not get the 3 patents and had it
canceled to claim the 11 leagues the draftsmen
men nine having no date but the 6th
of Deuel Robinson and the labor calling
for the corner of Deuel Robinson the labor
plead the labor adjoining the Robertson as
it was stated with in an error occurring
from the fact that the 3 leagues of Robinson
was altered and changed after the labor
which called on it had been patented
all those parties claiming any of those surveys
are perfectly aware of the existence of
the robsons grant of 11 leagues and
have at all times given them notice thereof
but it is their opinion that the claim is
imperfect as you know such titles
have been frequently held and are more
encouraged in this case as myself and no one
else have ever found any marks of survey
for said claim on the premises or elsewhere
in which deficiency this grant forms the only
exception in my district or acquaintance
the survey when all seem to the corners and lines
found at different times and also not cannot
conflict unless there be another survey in the name
of Deuel at the V W corner of Johnson of which
i have an impression that it was withdrawn
if not the Richardson they would conflict a little at
its S E corner Waco March 3rd 1856
