Field notes of the County line between  
Upshur and Gregg Counties as agreed on  
between A. S. Taylor, Commissioner on  
the part of Gregg County and S. B.  
Scott and A. A. Garrison Commission-  
ers on the part of Upshur County.

Beginning in Prairie Creek where the  
North Marshall & Gilmer Road crosses the  
same 1000 varas South and 50 varas  
West from the North East corner of 640  
acre survey made in the name of Charles  
A. Cooper from which a White Oak bears  
North  $22\frac{1}{2}^{\circ}$  E 10 vrs, marked U. C. a Sweet  
Gum bears S.  $24^{\circ}$  E. 6 vrs, marked G. C.

Thence running S.  $32^{\circ}$  W. 6 miles to a point  
12 miles from Gilmer, on a direct line to  
Longview, a Pine for a corner from which  
another Pine bears N.  $59^{\circ}$  W.  $24\frac{1}{2}$  vrs dis-  
tant marked U. C. another Pine bears  
S.  $83\frac{1}{2}^{\circ}$  E. 19 vrs distant marked G. C.  
Thence running S.  $70^{\circ}$  W.  $10\frac{1}{4}$  miles to the  
North East corner of Smith County, the  
above line is marked with three <sup>posts</sup> and on  
all public roads where the line crosses the
